Block will be held until 10/15/09, so make your reservations early to get the special rate. Hotel does not have airport shuttle. Use Super Shuttle. **SPECIAL NOTES:** County Ordinances forbid smoking in the show hall. Smoking is permitted in designated areas only. The Travis County Exposition Center is located on Decker Lane / FM 3177, between US 290 E and Webberville Rd / FM 969 (eastward extension of MLK Blvd).

**GENERAL INFORMATION:** CFA Show Rules will be strictly enforced. Show Rules may be obtained by sending \$5.00 to CFA, P.O. Box 1005, Manasquan, NJ 08736-1005. Please print or type all entry blanks. Exhibitors will be called collect in the event of a question regarding an entry.

All Championship, Premiership, and registered kitten entries will be scored for CFA National & Regional Awards. Registration number of cats must be printed in the catalog. Registration numbers for kittens can be submitted at the show to the master clerk. It is the exhibitor's responsibility to check entry confirmation and notify the entry clerk of any errors.

Judges not named may be added for Non-Championship and Premiership classes. Ribbons/Rosettes will be awarded as defined in CFA Show Rules. Permanent ribbons will be used, but fabric ribbons will be available upon request. Kittens under the age of four months on the opening day of the show will not be allowed in the show hall. Only exhibitors may bring cats and kittens for sale. They may be subject to veterinary inspection and proof of age may be required.

All claws must be clipped prior to benching. Declawed cats/kittens are not eligible for entry. It is strongly advised that all cats/kittens entered be inoculated against feline enteritis, rhinotracheitis, calici viruses and rabies. It is also recommended these entries be tested for FeLV and found negative. The State of Texas requires rabies vaccination for dogs and cats over 3 months of age. We strongly recommend that a rabies vaccination certificate be brought with each entry in case of inspection by local or state officials.

Reasonable care will be taken of cats and personal property, but the Eyes of Texas Cat Club Inc. will not be liable for loss or accident to a cat, exhibitor, or their personal property. Benching assignments will be made by the Show Management, and no change will be made without permission of the Show Manager. No refunds for failure to bench.

Cage sizes are 21" x 21" x 24", but may vary. Litter will be provided. Bring litter pans, cat food, etc. The show hall is climate controlled by heating and air conditioning systems.

No outside food or drinks may be brought in or consumed in the show hall. Concession food will be available. Grand parties allowed on limited basis. Absolutely no alcohol allowed in the show hall.
