GENERAL INFO: Our wire cages are large 27" x 27" x 27" single, 27" x 27" x 54" double. Litter will be furnished. Please bring your own litter box, food dishes and cage curtains.

HOUSEHOLD PETS: All household pets must be 4 months of age or older. Those over 8 months of age must be spayed or neutered. No declawed cats allowed.

Reasonable care will be taken of all cats and personal property. However, neither the Amarillo Cat Fanciers nor the Civic Center will be liable for items lost, damaged or stolen. Show hall is climate controlled and handicapped accessible. EMERGENCY PHONE 806-378-4246.

This show is licensed by the Cat Fanciers Association, Inc. (CFA), and its show rules will be strictly enforced. A copy of these may be obtained by sending \$5.00 to CFA, Box 1005, Manasquan, NJ 08736-1005.

All Championship, Premiership and registered Kitten entries will be scored for CFA National and Regional awards. Ribbons and Rosettes will be awarded according to CFA rules. Kitten registration numbers must be printed or written in ink in the master catalog to be scored. All AOV and Miscellaneous Cats/Kittens must have registration numbers to be eligible for entry. Kittens under four (4) months of age will not be allowed in the show hall.

Exhibitors with cats/kittens for sale must have at least one CFA registered cat or kitten entered in this show. One adult or two kittens per sales cage. No cat or kitten may be sold in the show hall for less than \$100.00.

No veterinarian inspection. All cats must be free from parasites, fungus and contagious diseases. The show committee reserves the right to remove any cat or kitten from the show hall if suspected of having any of the above until examined by a veterinarian at the owners expense. All cats and kittens should be inoculated against Feline Enteritis, Calici Virus, Rhinotracheitis/Pneumonitis, Rabies and tested for FeLV prior to the show. Front and rear claws of all entries must be clipped prior to benching. Declawed cats and kittens are NOT ELIGIBLE for entry in ANY CLASS.
