**CAGE SERVICE:** Provided by Double “S” Interprises.

**SHOW HOURS:** Check-in -Sat. 11:30 to 12:30AM(Not Before) - Show Hours: – Late Start - Sat 1 PM to 8 PM, Sun 9AM to 5:00PM. All entries are expected to remain in the show hall until the advertised closing time. Early departure without permission of the show manager will result in all wins being voided. Kittens and HHPs are exempt from this rule.

**SHOW HALL:** Resistol Exhibition Hall A is handicapped accessible and heated & air conditioned. Smoking is not permitted in the show hall. The concession stand will have a selection of food. **You are not permitted to bring in food for lunch or Grand Parties.** **CAKES** are permitted with approval from Show Manager. Litter will be provided; please bring your own litter pans, cat food and cage curtains.

**NO KITTENS UNDER 4 MONTHS** of age will be allowed in the show hall. This law will be strictly enforced. Only those cats/kittens entered in the show will be allowed in the show hall.

**THIS IS A NON-VETTED SHOW.** All entries should be vaccinated by a licensed veterinarian against feline panleukopenia, feline rhinotracheitis, calici virus and rabies, and be tested for feline leukemia before entry. Cats must be free of fleas, ear mites, fungus and any contagious illness. All claws must be clipped. Declawed cats are not eligible for entry (including HHP).

**ENTRIES:** All fees must accompany the entry. **No entry fee will be refunded for failure to bench.** There will be a \$25.00 Charge for returned checks. Please inform the entry clerk if you are bringing your own cages. Please note: Security cages require the purchase of an extra ½ cage space.

**SHOW HALL DIRECTIONS:** to 1700 Rodeo Dr, Mesquite, TX 75149. **FROM WEST** Ft. Worth/Arlington), take Interstate 30 East, exit onto I-635 head south. Take exit 4, stay straight. Showhall is on right, behind Hampton Inn & Suites. **FROM EAST** on I-30, take I-635 exit going south, exit 4 same as above. **FROM NORTH** take I-35E or US 75 south to Interstate 30, follow directions from the west. **FROM SOUTH** Take I-35E or I-45 north to I-20, then head east on I-20 toward Dallas to I-635 exit 480 stay right. Take Exit 3 at W. Cartwright/Burton Rd. Turn left of W. Burton, go to Hickory Tree Rd/Rodeo Center Blvd, turn right. Stay straight to Rodeo Rd on left.

**SCORING and AWARDS:** Championship, premiership and registered kitten entries will be scored for CFA national and regional awards. Ribbons and rosettes will be awarded according to CFA rules. This show is licensed by the Cat Fancier’s Association, and its show rules will be strictly enforced. A copy of CFA show rules can be obtained for \$5 from CFA, Box 1005, Manasquan, NJ 08736-1005, or at [www.cfainc.org](http://www.cfainc.org). All championship, premiership, provisional breed, miscellaneous and AOV entries must be entered with a CFA registration number.

**SHOW HOTEL:** There is not an official Show hotel or motel for this show. There are a number of hotels and motels in the area that accept pets, particularly LaQuinta Inn on I-30 and Motel 6. LaQuinta runs some great specials during this time, we will keep you notified through the group listing.

**FLY – INS:** Rental cars are available at Dallas-Fort Worth Airport through online websites, such as rental car websites or [www.travelocity.com](http://www.travelocity.com) or [www.orbitz.com](http://www.orbitz.com) .

**SUPPLIES:** Litter will be provided. Bring your own litter pans, cat food dishes and water dishes. Single cages are 22 x 22 x 22, double cages are 22 x 45 x 22. Bring cage curtains of your choice to cover the cage sides, back and top.

New exhibitors may request a copy of “Helpful Hints” from CFA. Please inform the show manager on check in that you are a new exhibitor and the show committee will help you with your needs.
