SHOW HALL: The Crown Plaza – Denver Airport is a handicapped accessible and heated & air conditioned. Smoking is not permitted in the show hall. The hotel will have a selection of food available. Grand parties are welcome. Litter will be provided; please bring your own litter pans, cat food and cage curtains.

All entries are expected to remain in the show hall until the advertised closing time. Early departure without permission of the show manager will result in all wins being voided. Kittens are exempt from this rule.

NO KITTENS UNDER 4 MONTHS of age will be allowed in the show hall. This rule will be strictly enforced. Only those cats/kittens entered in the show will be allowed in the show hall.

THIS IS A NON-VETTED SHOW. All entries should be vaccinated by a licensed veterinarian against feline panleukopenia, feline rhinotracheitis, calici virus and rabies, and be tested for feline leukemia before entry. Cats must be free of fleas, ear mites, fungus and any contagious illness. All claws must be clipped. Declawed cats are not eligible for entry (including HHP).

ENTRIES: All fees must accompany the entry. No entry fee will be refunded for failure to bench. There will be a \$50.00 charge for returned checks. Please inform the entry clerk if you are bringing your own cages. Note: Security cages w/1 entry require the purchase of an extra ½ cage space.

SCORING and AWARDS: Championship, premiership and registered kitten entries will be scored for CFA national and regional awards. Ribbons and rosettes will be awarded according to CFA rules. This show is licensed by The Cat Fanciers' Association, Inc., and its show rules will be strictly enforced. A copy of CFA show rules can be obtained for \$5 from CFA, Box 1005, Manasquan, NJ 08736-1005, or at www.cfainc.org. All championship, premiership, provisional breed, miscellaneous and AOV entries must be entered with a CFA registration number.

SHOW HOTEL: Crowne Plaza – Denver Airport, 15500 East 40th Avenue, Denver, Colorado 80239. Telephone: (303) 371-9494. A block of rooms is reserved for this event. Show rate is \$97.00/night plus tax for up to 2 person occupancy, \$105.00/per night for 3 persons and \$110.00/per night for 4 persons. The pet deposit is WAIVED; however, per our contract, any damage or cleaning charges will be charged to the individual's room. There is a maximum of 4 pets per room allowed.

FLY-INS: Fly in/out of Denver International Airport. Call hotel upon arrival for the Crowne Plaza free airport shuttle pickup.

SUPPLIES: Litter will be provided. Bring your own litter pans, cat food dishes and water dishes. Single cages are 22 x 22 x 22, double cages are 22 x 45 x 22. Bring cage curtains to cover the cage sides, back and top. Please inform the show manager at check-in that you are a new exhibitor and the show committee will help you with your needs.
