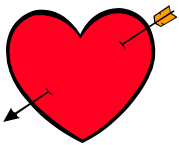

All championship, premiership and registered kittens will be scored for National and Regional Awards. This is a CFA licensed show and CFA show rules will be strictly enforced. . This is a non-vetted show. It is strongly advised that all cats/kittens entered be inoculated against feline enteritis, rhinotracheitis, calici viruses and rabies. It is also recommended these entries be tested for FeLV and found negative. Cats must be free of fleas, ear mites, fungus, and any contagious illness. All claws must be clipped. Declawed cats are not eligible for entry. No kittens under the age of 4 months will be permitted in the show hall.
