FROM THE NORTH

Take I-45 South, exit 610 Loop East

Take 610 Loop East, exit Hwy 225 East

Take 225 East, exit Center Street

Turn right on Center Street, turn right on 13th Street

past the Fire Station

FROM THE SOUTH

Take I-45 North, merge onto TX-8 N/E Sam Houston Tollway N via EXIT 32

Take the exit toward Pasadena Blvd/Red Bluff Rd.

Merge onto E Sam Houston Pkwy S.

Turn right onto Green Shadow Dr.

Green Shadow Dr. becomes W 13th St.

Jimmy Burke Activity Center is on the right-hand side

Show Rules:

This is a CFA licensed show and all CFA show rules will be enforced. A copy of the show rules may be purchased for \$7 from CFA. All entries in Championship (except Novice), Premiership (except Novice), Agility (if offered), *registered* Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. The Club reserves the right to add or substitute judges not named in the show flyer should it become necessary.

Cages and Supplies:

Exhibitors are responsible for providing their own benching enclosures. A standard benching space is 22"x22"x22" (Show Rule 5.01j); a double space is 22" x 22" x 45".

Wire cages ARE NOT available to rent; alternatively, you may purchase an inexpensive pop-up for \$20 at the show hall or bring your own. Use of purchased enclosure requires payment of "extra half cage" fee. Please indicate in notes to entry clerk if you wish to buy an enclosure at the show hall. Litter will be provided; bring your own litter pans, cat food and cat dishes.

Health Information:

This is a non-vetted show. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All entries must be free of fleas, ear mites, fungus, or any contagious or infectious illness. All claws of all entries must be clipped prior to benching. Declawed cats are not permitted in the show hall. No kittens under the age of 4 months will be permitted in the show hall.

Entry Information:

It is the exhibitor's responsibility to contact the Entry Clerk to confirm receipt of online/fax entries. Neither the Entry Clerk, the Coastal Cat Club, nor the Gulf Coast Feline Foundation will be responsible for entries lost due to communication errors. Per show rule 6.21, all entries must be accompanied by proper entry fees.

Entries sent online or faxed must be paid in full within 10 days of receipt or prior to the show, whichever is first. Make checks payable to **Coastal Cat Club** and mail to Entry Clerk or send via PayPal to michelle@gulfcoastfeline.org. *There will be a \$50 fee for returned checks.* No substitutions will be accepted after closing date. No refunds made once your entry is received or for failure to bench.

Liability:

Coastal Cat Club and the Gulf Coast Feline Foundation will take reasonable care to safeguard entries and the property of exhibitors. Neither the Coastal Cat Club, the Gulf Coast Feline Foundation, nor the City of Deer Park will be liable for any loss, damage or injury. Exhibitor will be responsible for any damages caused to the property.
